The One Big Beautiful Bill Act (OBBBA) passed in July of 2025 creates a number of IRS tax changes. Key features for individuals include making many tax cuts from the 2017 Tax Cuts and Jobs Act permanent, and introducing new and increased tax deductions. Specific deductions impacting individual tax returns include increased state and local tax deductions (up to \$40,000 now), and deductions for interest on new car loans. Some taxpayers over age 65 will receive an additional \$6,000 tax deduction (depending on income). The child tax credit (16 and younger) increases to \$2,200. Tipped employees can be eligible for an additional \$25,000 deduction. Overtime wages can be eligible for an additional \$12,500 (single) or \$25,000 (married) deduction.

NO MORE IRS PAYMENTS/ESTIMATES/REFUNDS BY CHECK. Bank information is required for direct deposit/payments. We can also set up estimates to be paid on final day due. The IRS website can be used for payments/estimates as well.
